## 2: Hazard identification

### DANGER:

### 4: First-aid measures

---

- Eyes:** My cause eye damage based on data of similar material. Flush immediately with water for 15 minutes. Get medical attention.

### 5: Fire-fighting measures

---

- Flash Point:** >63<sup>0</sup>C
- Auto ignition temperature:** >200<sup>0</sup>C
- Flammable limits in Air % by Volume:** 0.6 – 0.7% vol/vol
- Extinguishing media:** Use foam, CO<sup>2</sup>, Dry Chemical or Foam to extinguish fire.

## 6: Accidental release measures

---

If product is released or spilled:

Personal Protection Equipment must be worn. See Section 8 for details.

Ventilate area if spilled in confined space or poorly ventilated area.

## 7: Handling and storage

---

### Handling

Not classified as Hazardous or Dangerous Goods. Slippery when split. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and inhalation of vapours.

### Storage

Store in a cool dry well ventilated place and out of direct sunlight. Store away from acids, oxidising agents and foodstuffs.

## 8: Exposure controls and personal protection

---

**Engineering Controls:** Use only with adequate ventilation. Product is combustible.

**Eye / Face Protection:** Avoid contact with the skin and eyes, and avoid breathing vapours and mists. When exposure is likely, use personal protective equipment in a combination appropriate to the exposure. Nitrile gloves and Safety glasses.

**Body Protection:** Coveralls in an emergency involving very high concentrations.

**Respiratory Protection:** Not usually required. Use SCBA in an emergency involving very high concentrations.
